I am pleased to report, that through the contributions of the both the 3rd & 4th Degree, we raised over \$5,400 for this project. This accomplishment will result in the Hot Springs Village Knights of Columbus being permanently recognized, within the memorial itself, as one of only two "Gold Level" sponsors of this project. Personally, I believe this project embodied portions of all four of our guiding tenants, Charity, Unity, Fraternity, and Patriotism. Both the Council and the Assembly have every right to feel a real sense of pride and honor in this accomplishment.

We sent representatives to the Grand Knight's Meeting August 21st. The Meeting was hosted by Council 6398 in Russellville. There was opportunity for council officers from across the state to network with their counterparts, and insight was provided by Supreme on the "ins-and-outs" of council operations.
